



## Membership Policy

Jan 2017

### Objective:

To define the Central Coast Speedway Kart Club membership Classifications and Fees.

### Audience:

All Club members.

### Review:

All Classifications and Fees are reviewed annually at the AGM.

### Classifications:

#### Full Member

- a) A Full Membership can be for either a Single person or Families.
- b) A Full Family Membership can be for up to six people (spouse/partner, dependent children or siblings), all living at the same postal address.
- c) A Membership fee must be paid for each Calendar year to remain Financial.
- d) The Membership fee for Singles is currently \$70 for one year and \$135 for two years.
- e) The Membership fee for Families is currently \$90 for one year and \$175 for two years.
- f) Each Single or Family Membership is entitled to one vote at all Committee Meetings.

#### Honorary Member

- a) Each AGM, Honorary members may be nominated, and voted for approval, for the following Calendar year.
- b) Honorary Members are usually nominated for their dedication towards, and support of the Club in previous years.
- c) Once approved, an Honorary Member pays no Membership fees for that Calendar year.
- d) Honorary Members are considered Financial, and are entitled to one vote at all Committee Meetings.

#### Life Member

- a) Each AGM, Life members may be nominated, and then voted for approval.
- b) Life Members are usually nominated for their dedication towards, and tireless support of the Club over 5-10 years or more.
- c) Once approved, a Life Member pays no further Membership fees.
- d) Life Members are considered Financial and are entitled to one vote at all Committee Meetings.

#### Social Member

- a) Social Members are Single persons, who do not drive or compete at any race meetings.
- b) A Membership fee must be paid for each Calendar year to remain Financial.
- c) The Membership fee is currently \$20 for one year and \$40 for two years.
- d) Social Members are entitled to one vote at all Committee Meetings.



### **Membership Conditions:**

- a. **Membership Application forms -**
  - i. **Honorary & Life Members must complete a new form when requested.**
  - ii. **All other Members must complete a form upon Membership application or renewal.**
- b. **Members must always abide by the Club Constitution and all Club Policies in force at the time.**
- c. **A member is not entitled to vote at a Committee Meeting if they are under 18 years of age.**
- d. **Members must be in attendance to vote at Committee Meetings, as proxy voting is not permitted.**
- e. **Memberships, once approved, are valid from the date of application, and will need to be renewed no later than the Anniversary of that date, in the Calendar year due.**
- f. **Membership renewals paid after the Membership expires, will only be reinstated, if paid within seven calendar days. Otherwise, a lapse in Membership will occur and a new renewal date will be established.**
- g. **All Members are entitled to vote for any Club end of year speciality awards / prizes.**
- h. **Eligibility for Awards, Prizes and Discounts**
  - i. **All Members must be considered Financial for the duration of the Calendar year.**
  - ii. **All Full, Honorary & Life Members are eligible for all Club awards / prizes / discounts.**
  - iii. **Social Members are not eligible for awards & prizes related to the Club Championship.**
